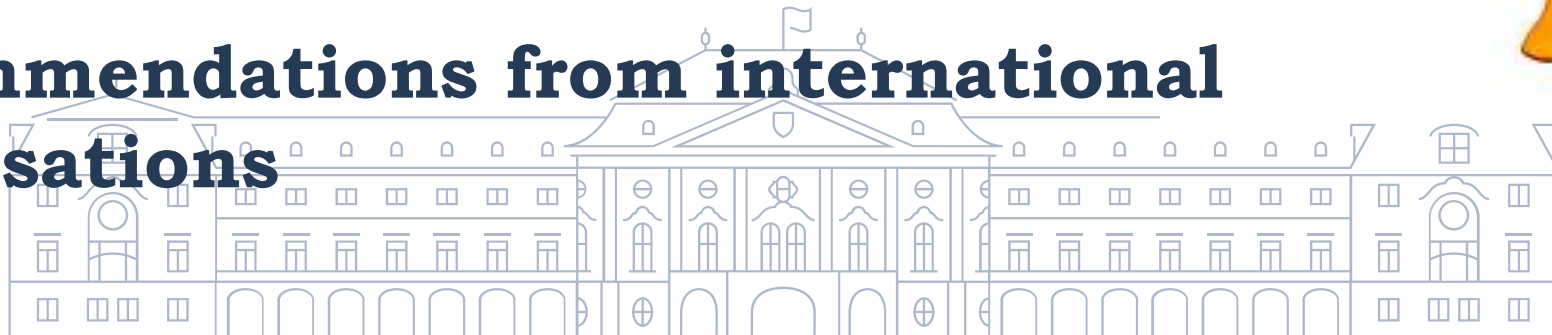
AN INTEGRITY STRATEGY FIT FOR 21ST CENTURY



Before the real work on preparation of our AC Strategy started

Factors that need to be taken into account in the launching of the whole process:

- **Experiences from the implementation of previous strategy**
- **Actual problems and difficulties in the area of corruption raised up from the discussion with relevant stakeholders**
- **SWOT analyses results**
- **Recommendations from international organisations**





THE ANTI-CORRUPTION POLICY OF THE SLOVAK REPUBLIC

- Based on the concept that **effective prevention of corruption is much cheaper than the repression**
- Adopted by the **Resolution** of the Government of the Slovak Republic **No. 585/2018** in December 2018
- Sets out **strategic bases** for all AC activities across the public sector in the SR
- Main addressee is **public administration** + all levels of public authorities

1st Priority

To promote and protect public interest through reducing the room and opportunities for corruption



2nd Priority

To improve quality of legislative environment



3rd Priority

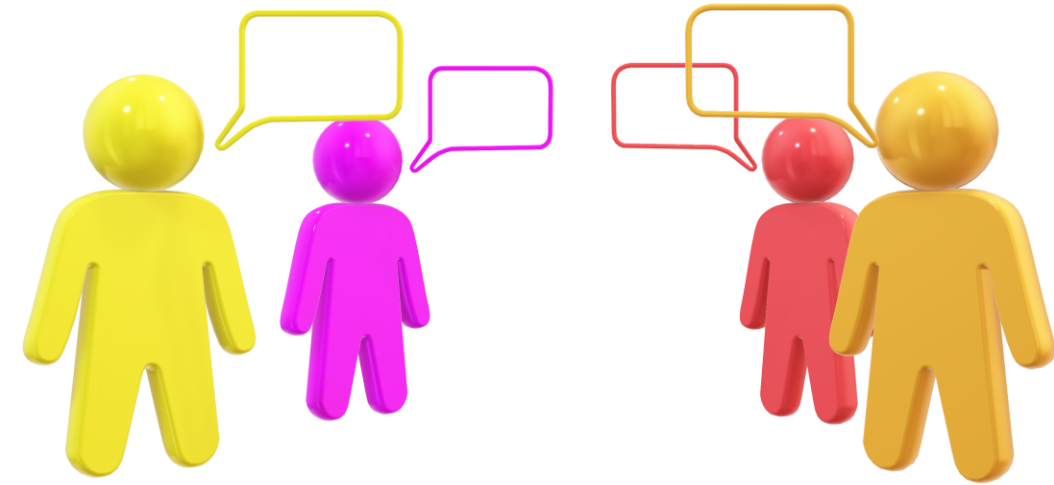
To improve conditions for doing business



THE ANTI-CORRUPTION POLICY OF THE SLOVAK REPUBLIC

To implement this policy properly we had to set up:

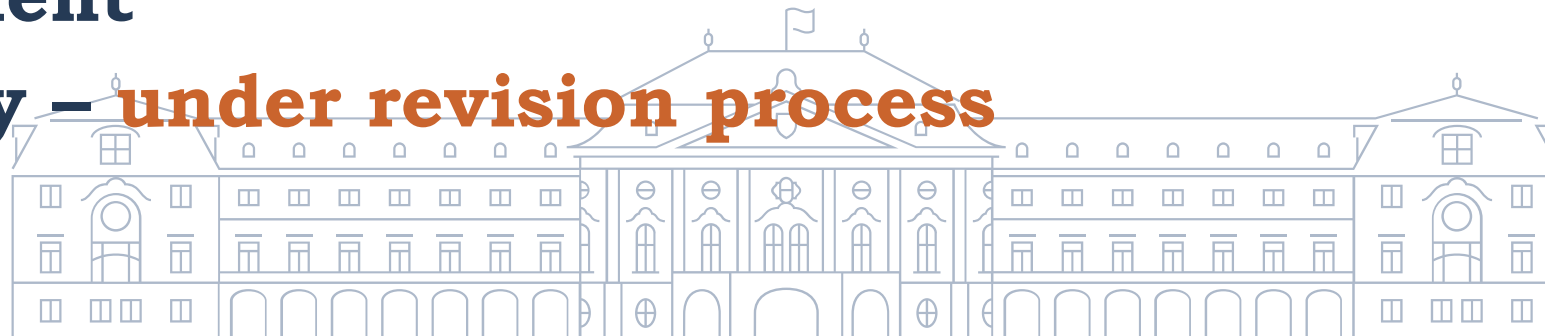
- Board of **Anti-Corruption Coordinators**
- Mandatory management of **corruption risks**
- **Sector-Specific Anti-Corruption Programme**
- **National Anti-Corruption Programme**





THE NATIONAL ANTI-CORRUPTION PROGRAMME OF THE SLOVAK REPUBLIC

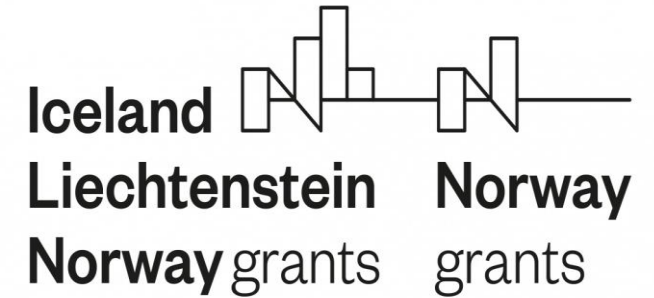
- **ACTION PLAN** – adopted by the Resolution of the Government of the Slovak Republic No. 426/2019
- Entails **specific measures** which go beyond the scope of individual sector's AC programmes (**Bill on Lobbying**)
- Published on the website of the Slovak Government
- **Currently – under revision process**





IMPROVING INTEGRITY IN PUBLIC ADMINISTRATION OF THE SLOVAK REPUBLIC

- Project financed by the **EEA and Norway Grants**
- **OECD** – project partner
- Preparatory work on the publication „**Integrity Review of the Slovak Republic**“
- **6 key activities** – Integrity Review, Pilot initiative on behavioural insights, citizen survey, internal risk management, communication and civic education
- Fundamental bases for next **AC strategy/policy** of the Slovak Republic
